Those wishing to participate in the Conference seminars are invited to submit 200-word abstracts of their proposed papers directly to all convenors of the seminar in question before 28 February 2014. The convenors will let the proponents know whether their proposals have been accepted by no later than 31 March 2014.

Please note the ESSE rules for the seminars:

authors of seminar papers will be expected to give an oral presentation of not more than 15 minutes' duration, rather than simply read their papers aloud. Reduced versions of the papers are circulated among all speakers in advance of the seminar in question, during July/August 2014. The convenors will also allocate a respondent to each individual paper from among the seminar participant who will comment on the paper. There will be a maximum of 5 papers in each two-hour seminar session, and convenors should plan so that there is time for discussion between speakers and with the audience.

For abstracts of individual papers at seminar sessions and PhD students' sessions and posters: 28 February 2014.

Confirmation of acceptance of abstracts by seminar convenors and PhD session convenors: 31 March 2014.

Registration will begin on 1 April 2014.

Applications for fee waivers: 1 April 2014 - 15 April 2014.

Early registration: 1 April 2014 - 31 May 2014. Late registration: 1 June 2014 - 29 August 2014.
